Next generation supports Israel Bonds

PASSING THE TORCH from generation to generation, or L'Dor V'Dor, can produce a lasting benefit for an entire Jewish community.

This was the theme of the Sunday, Dec. 8, tribute dinner in honor of Shep Lesser and his son, Gary, that was given by the New Leadership Division of the State of Israel Bonds.

Bonds investors say there is much to celebrate this year; there were \$30 million dollars in bond sales the largest total in the history of the Palm Beach Region. Also, 2,000 people purchased bonds.

Among the 130 attendees at the black-tie event were newly-elected U.S. Rep. Robert Wexler, Florida Rep. Elaine Bloom and Israel Consul General Ruhama Hermon. "In every generation we are looking for a symbol for the story of Hanukkah," Hermon said during the fourth night of the festival of lights. "In this generation, our miracle is the State of Israel."

Eric Matheson, local New Leadership Chairman, said the reason for holding the dinner and other new leadership events is to continue the family tradition of having a commitment to Israel.

Matheson himself comes by this tradition through his own family. His father, Bill, has for years held national leadership posts.

"It's important that young people become involved with bonds in Palm Beach. It's important that we keep coming back and that as young people we continue what our grandparents and parents started," Eric Matheson told the bonds supporters at the event.

Investing in Israel Bonds, he pointed out, is also good business. This can easily be seen in the burgeoning business interests from Motorola, Intel, Microsoft and other companies expanding in Israel.

The Lessers were commended for exemplifying the highest level of community service and advancing the cause of Israel.
